

AMBOY COMMUNITY UNIT SCHOOL DISTRICT #272

PROOF OF RESIDENCY

A person who knowingly or willfully presents to any school district any false information regarding the residency of a pupil for the purposes of enabling that pupil to attend any school in that district without the payment of a non-resident tuition shall be guilty of a Class C misdemeanor. (Public Act 89-0480) (105 ILCS 5/10-20.12b(e))

Before a child may register and attend our school the following conditions must be met:

- You must be a resident of Amboy Community Unit School District #272
- You must submit a completed CERTIFICATE OF LEGAL RESPONSIBILITY
- You must be able to present proof of residency within the District by providing the required number of documents from Category I and Category II as listed below

Acceptable examples of proof of residency include:

Category I – One (1) document required

- *Homeowner* - A current tax bill with the property owner's name and address and proof of payment (canceled check or Form 1098)
- *Homeowner* - Current mortgage papers (homeowners)
- *Renters* - Signed and dated lease indicating the parent, legal guardian or legal custodian's name and proof of last month's payment, e.g. cancelled check or receipts. Lease must indicate length of lease. If the parent or legal guardian is not the lessee the lease must indicate the names of all individuals residing at the address. If there is not a lease, please provide the LANDLORD VERIFICATION.
- *Mobile Home Park Residents* - MANAGER VERIFICATION and proof of last month's payment, e.g. canceled check or receipts.
- *Residing with District Resident* - If you are residing with a family member and all forms of legal residency are in their names, the district resident must complete PROPERTY OWNER VERIFICATION. It will also be necessary for the district resident to provide the above items as proof of residency. (Owner occupied status removed from your property tax bill.)

Category II – Two (2) documents required

- Driver's License with address within district or vehicle registration with address within district
- Current Voter registration card, current Public Aid card, or current library card
- A current (within 60 days) utility bill (gas, water,) indicating the head of household's name and service address or most recent cable television and/or credit card bill with address within district
- Receipt for moving van rental
- Mail received at new residence

If you have a custody order and are seeking to enroll a student, please complete a CERTIFICATE OF LEGAL RESPONSIBILITY and present required proof of residency as well as a court order, agreement, judgement, or decree that awards or gives custody of the student to any person (including divorce decrees awarding custody to one or both parents.)

If you are establishing residency for a student that is not your child, please complete a CERTIFICATE OF LEGAL RESPONSIBILITY and present required proof of residency.

Families who live out of district and are planning to establish residency should see the requirements as outlined in Amboy CUSD #272 Board Policy 7:60. It will be necessary to provide the above documents to establish residency within the district.

Additional documents may be requested as deemed necessary by the school district on a case-by-case basis, if the school district has reason to question a student's residency.

Additional Requirements:

- Parents/Guardians of ALL NEW students entering any grade level in Amboy CUSD #272 and ALL students entering Kindergarten are required to establish residency, even if the family already has other students enrolled in Amboy CUSD #272.
- Any student who has been previously enrolled in Amboy CUSD #272, left the district for any reason and is returning, must reestablish residency.
- Any currently enrolled student who changes addresses within the district at any time will also be required to prove residency.

6. I will immediately notify the school principal if such student no longer resides with me.
7. I understand that if this child is found to be illegally registered, he/she will be immediately removed from the educational programs. I understand that I will be held responsible for illegally enrolling the student in the program.
